Area(s), (See map):

- General area where the activity has occurred.
- For example...The incidents have occurred in Division One, Beats 713, 809, and 813.


List of Incidents: The table headings and their order can be changed according to the type of activity. For example, the "Other" category can be changed to reflect Property Taken or Type of Weapon.


